BodyTherms, LLC Protocol for Day of Thermography Breast Exam

Thermography is an Adiunctive breast health exam in addition to your annual Mammogram.

- An exam should not be done on the first day of your period in most cases
 - (Ideally, get your thermography days 4-24 of your cycle)
- Avoid a hot shower at least 4 hours prior to exam
- Do not use lotions, hormone creams, or powder on your breasts on the day of the exam
- Avoid application of deodorant or antiperspirant (even crystal deodorant) if possible
- Avoid coffee or tea, hot or cold for 4 hours before exam -- no caffeine
- Do not shave on the day of the exam to avoid skin abrasions
- No physical stimulation or treatment of the breasts, chest, neck, or back for 24 hours prior to the examination (no chiropractic, acupuncture, TENS, physical therapy, electrical muscle stimulation, ultrasound, massage, or ice or heat use)
- · Avoid sun exposure for extended periods of time the day before and on the day of the exam -- no sunburns
- No heated seats on the way to exam, or hot liquids
- Please provide a list of medications either prior to or at the time of the exam
- Notify the technician if you are taking Beta Blockers
- Do not smoke for 4 hours before exam
- Do not plan a heavy workout the day of the exam
- Notify Cindy if you have a current skin lesion, rash or injury to the breast

For the exam, you will need to disrobe from the waist up and acclimate to room temperature (68° - 72° F) for \sim 15 minutes. The scan will take approximately 15-20 minutes.

If you are disabled or unable to sit or stand for long period, notify Cindy.

You are welcome to bring a companion to be present during the exam. The process is non-invasive and non-contact.

Test Results:

Once your scan in complete, it will take approximately 2 weeks before your report will be available.

(Rush Fee is \$100 and time frame is 3-5 business days)
